### Request for Inclusion of Downing Park to National Heritage Area

Dear Andy Kitzmann,

As outlined more fully in the attached, we request inclusion of Downing Park in the Hudson River Valley National Heritage Area.

From September 13- 15, 2024, the Olmsted Network and hundreds of friends from across the country were delighted to visit Newburgh as part of our national conference — <u>Landscapes of Renewal: Olmsted, Vaux, and Downing</u>. Our day in Newburgh included talks, music, guided tours of the park and a dinner cruise along the Hudson River, giving us an appreciation of what the city has to offer to both its citizens and visitors. There was nature and history abound, and it was amazing to experience so many of America's 19<sup>th</sup> century iconic landscapes and buildings after only knowing them from books and photographs.

Much to our surprise, despite its national significance, Downing Park has yet to be listed on the National Register of Historic Places, the list of our country's most important historic properties. We also note that Downing Park is not included in the Hudson River Valley National Historic Area. Accordingly, we write to request that it be added to the Maurice D. Hinchey Hudson River Valley National Heritage Area.

As requested, we are attaching the completed form for your consideration.

We and our friends from across the continent believe that designation of Downing Park to the Hudson River Valley Heritage Area would go far to enhance the public's understanding and appreciation of the park's role in the history of the Hudson Valley and the country.
